

# **Pebble Lake Golf Club**

## **2026 Membership Terms & Conditions**

### **Introduction**

This Membership Terms & Conditions Agreement (“Agreement”) governs all memberships, passes, trail fees, storage privileges, cart privileges, facility access, reservations, and use of Pebble Lake Golf Club (“PLGC” or “Club”) property, systems, equipment, and services for the 2026 season.

By purchasing a membership or pass; including through online or electronic payment; Member acknowledges that they have read, understand, and agree to these Terms & Conditions. No separate signature is required. Electronic purchase constitutes binding acceptance of this Agreement.

Membership at PLGC is a privilege, not a right.

### **1. Assumption of Risk & Release of Liability**

Golf and related activities involve inherent risks, including but not limited to injury from golf balls or clubs, cart accidents, slips and falls, uneven terrain, weather hazards, equipment failure, actions of other participants, serious bodily injury, permanent disability, or death.

Member voluntarily assumes all risks associated with use of the Club.

To the fullest extent permitted by law, Member releases and discharges PLGC, its Board of Directors, officers, employees, volunteers, contractors, agents, and representatives from any claims or liabilities arising from use of the Club, whether caused by negligence or otherwise.

### **2. Indemnification**

Member agrees to indemnify and hold harmless PLGC from any claims, damages, or losses arising from Member conduct, guests, minor children under supervision, improper cart use, improper sharing of privileges, or damage to Club property.

### **3. Membership Use & Non-Transferability**

All memberships, passes, trail fees, cart privileges, range passes, and storage privileges are non-transferable, may not be shared, and have no cash value.

Improper sharing or fraudulent use may result in immediate suspension or permanent revocation without refund.

#### **4. Suspension & Revocation**

PLGC reserves the right to suspend or revoke membership for rule violations, unsafe behavior, repeated no-shows, abuse of facilities, alcohol violations, or failure to pay fees. Suspension or revocation may occur without refund.

#### **5. Tee Times, No-Shows & Cancellations**

Repeated no-shows or excessive late cancellations may result in booking restrictions or suspension. Membership does not guarantee unlimited access and is subject to availability, maintenance, events, and operational needs.

#### **6. Weather & Course Conditions**

PLGC may close facilities due to weather or unsafe conditions. Membership fees are not refundable due to weather-related closures or shortened seasons. Members assume risks associated with outdoor conditions.

#### **7. Alcohol Policy – State Law Compliance (Minnesota)**

Pursuant to Minnesota Statutes § 340A.503, Subdivision 8, no person may consume alcoholic beverages on licensed premises unless purchased from the licensee.

Outside alcohol is strictly prohibited. Violations may result in removal, suspension, revocation, and referral to authorities. The Club must enforce Minnesota liquor laws to maintain its license.

#### **8. Golf Cart Use (PLGC and Private)**

Club carts may only be operated by authorized individuals. Private cart use requires a Trail Fee. Members are financially responsible for damage caused by negligent cart use.

The City of Fergus Falls requires a valid Drivers License and you must be 16 years of age to operate one on the course; this includes Private Carts.

#### **9. Cart Storage & Private Cart Facilities**

Storage is subject to availability. PLGC is not responsible for theft, fire, weather damage, or vandalism. Private carts are stored at Member's risk.

#### **10. Locker Storage & Personal Property**

PLGC is not responsible for theft, loss, or damage to personal property stored anywhere on Club property.

#### **11. Driving Range & Range Passes**

Range passes are non-transferable and may not be shared. Improper use may result in suspension or revocation without refund.

#### **12. Minor Children**

Parents or guardians assume all risks and financial responsibility for minors using Club facilities. PLGC does not provide general supervision outside structured programs.

**13. Fees, Sales Tax & Processing Charges**

All fees are subject to applicable Minnesota sales tax and may include processing fees as permitted by law. All fees are due prior to activation and are non-refundable except as required by law.

**14. Operational Discretion**

PLGC reserves the right to modify policies, adjust hours, close facilities, and enforce rules uniformly. Membership does not guarantee uninterrupted access.

**15. Binding Effect**

By purchasing a membership or accessing Club facilities, Members acknowledge acceptance of these Terms. Electronic purchase constitutes full agreement.
